



## National Concours 2022 Judging Instructions for Participants

**PLEASE NOTE ALL THE TIMES INDICATED BELOW AND:**

**1 - THE JUDGING OF YOUR CAR BY LAMBORGHINI CLUB AMERICA AT CONCORSO ITALIANO IS FOR ENTERTAINMENT PURPOSES ONLY. BY SUBMITTING YOUR CAR FOR JUDGING, YOU AGREE LAMBORGHINI CLUB AMERICA IS NOT PROVIDING ANY OPINION OF THE QUALITY OR ANY VALUATION OF YOUR CAR.**

**2 – ONLY CURRENTLY PAID UP LAMBORGHINI CLUB OF AMERICA MEMBERS ARE QUALIFIED TO SUBMIT THEIR CARS FOR LCA JUDGING AND TO RECEIVE AN LCA AWARD. You can join the club or renew your membership at:**

### **Judging Criteria**

The intent of the Lamborghini Club America (LCA) judging at Concorso Italiano (CI) on Saturday, August 20<sup>th</sup>, 2022 is to judge Lamborghini cars against their peers and to how they were originally designed and constructed. As a result, any aftermarket modifications that were not available as factory options may cause point deductions. Each vehicle to be judged shall be driven on to the show field. At the discretion of the judges, certain racecars are exempt from this requirement (such as Formula 1, Diablo GTR, Gallardo Super Trofeo, Huracan Super Trofeo, etc).

The judging of each car in each LCA Class will be performed by two or three designated LCA class judges. Overall organization and judging leadership is by Co-Chief Judges Roger Wiersema and Michael Palmieri. The LCA judges will examine each car judged following the Scoring Sheet categories and will deduct up to the maximum indicated points in each category. Details of the categories and points are on the Scoring Sheet provided in a separate document.

**Every year we seek new judges to be added to our LCA judging team, so please let us know in advance if you're interested and we can set up a call to explain the requirements and duties of an LCA Judge.**

Please note:

- The owner or person designated to show the car must be present during judging.
- If a car has non-standard modifications and/or features, the person showing the car shall be prepared to show the authenticity of it, or else point deductions may result.
- Normal replacement items such as battery, spark plugs, belts, hoses, etc., need not be the original brand, but should match the original specification.
- Items added for safety and/or security purposes such as seat belts, fire extinguishers, and alarms shall be allowed provided the installation is neat, unobtrusive, and keeping the general spirit of the car.
- Since all Lamborghinis are designed and constructed to be driven, some road dust and dirt is expected from the trip to the show field, so no point deductions will occur for that, although may count in tie breaker situations.

## **LCA Classes**

There will be four (4) LCA Classes to be judged. To the extent the Chief Judges deem appropriate, there will be awards of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> in each class. The classes will generally consist of the following cars but depending on how many cars from each class are registered for judging, the LCA Chief Judges will combine, eliminate, add, or split, or allocate cars from these groups as they deem necessary to achieve four classes that represent the marque appropriately for such groups.

## **Registration for LCA Judging of Your Car on Saturday, August 20<sup>th</sup>, 2022**

If you want your car to be judged, your car must be at CI on Saturday, August 20th, 2022 and you or your representative must:

**Between 8:15am to 9:15am** come to the LCA tent at CI and fill out your name and car details on a Scoring Sheet, including your cell phone number, and turn in your Scoring Sheet to the Co-Chief Judges, Roger Wiersema and Michael Palmieri. You may also do this in advance by completing the Scoring Sheet and sending it to [concoursjudging@lamborghiniclubamerica.com](mailto:concoursjudging@lamborghiniclubamerica.com), however, you still need to come to the LCA tent to confirm the information at 8:15am-9:15am (the cut-off for email submittal is 6:00pm PDT on August 16th, 2022).

**At 9:15am** judging of the cars will start for approximately 90 minutes (from 9:15am until 10:45am). Because of time constraints, your car will only be judged for approximately 7 to 10 minutes. You or your representative will need to be next to your car for judging during this time (your cell phone number will be used to contact you if you are not present but the judges will wait no more than 5 minutes before removing your car from the list to be judged). Please remain with your car until the judges have told you they have completed their judging. Upon completion, the judges will take a few minutes to talk you through their scoring of your car. Any cars that have been judged, at the owner's request to the Co-Chief Judges, will be emailed a copy of their scoring sheets approximately 2 weeks after the event.

**Between 10:15am and at 10:45am** you will need to come back to your car to see if you have won a CI and/or LCA award. If you have won a CI award, you will find a notice on your car no later than 10:15am. If you have won an LCA award, you will find a notice on your car no later than 10:45am. To receive your CI and/or LCA award, you will need to drive your car to the CI stage at the times designated below. If you are not available at any of these times, the judges will try to contact you but if unsuccessful they will move on to the next ranked car in their judging and your award will be forfeited.

## **LCA Awards**

For 2022, due to Covid restrictions at Serata Italiana, LCA will present all our awards on the CI stage in the afternoon, starting around 3:20pm. To be sure you receive your award please note the following LCA award schedule and please also note that you, or your representative, must be present to receive your LCA award. The awards will be for the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> places for each of the 4 LCA Classes (as described in the "LCA Classes" above), the LCA Judge's Choice and LCA Best of Show.

**At approximately 3:20pm** - if you are one of the 12 to 14 winning cars for the awards, you will need to drive your car to the CI stage. LCA judges will instruct you on the details. The LCA Class awards will be presented to each car on the CI stage approximately between 3:20pm-4:00pm followed by the LCA Judge's Choice and LCA Best of Show. If you are not available at any of these times, the judges will try to contact you but if unsuccessful they will move on to the next ranked car in their judging.

### **CI Marque Awards**

CI presents Marque awards for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> places for each Marque. The CI Marque awards are not judged by CI staff, but are judged by each Marque's club at their discretion.

**To best represent the Lamborghini Marque for CI, the LCA Chief Judges will decide, independently and in advance of the conclusion of the LCA judging, which three Lamborghinis will receive the CI Lamborghini Marque awards for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place.**

**PLEASE NOTE THAT AS A RESULT, THE CARS WINNING CI LAMBORGHINI MARQUE AWARDS MAY, OR MAY NOT BE, WINNERS FOR ANY LCA CLASS AND WHICH IS NO REFLECTION OF THE QUALITY OF ANY OF THE CARS, EXCEPT TO REPRESENT THE LAMBORGHINI MARQUE BEFITTINGLY FOR CI, AS DETERMINED BY THE CHIEF LCA JUDGES.**

**At 10:15am** - The LCA Chief Judges will place a notice on each CI Lamborghini Marque winning car and will call the three CI Lamborghini Marque winners around 10:30am and advise them accordingly. If any of these winners is not reached, the judges will call them again at 10:35am and again at 10:40am. If the judges cannot reach a chosen CI Lamborghini Marque winner by 10:40am, the LCA Chief Judges will select a replacement CI Lamborghini Marque winner and call the replacement CI Lamborghini Marque winners in the same order.

The CI Lamborghini Marque awards will be presented on the CI stage at the following times:

**At approximately 10:50am** - if you are receiving a 2<sup>nd</sup> or 3<sup>rd</sup> place CI Lamborghini Marque award, you will need to line up at approximately 10:50am to drive your car to the CI stage. The LCA Chief Judges will instruct you on the details. If you are not available at this time, the judges will try to contact you but if unsuccessful they will move on to the next ranked car in their judging.

**At approximately 2:15pm** - if you are receiving the 1<sup>st</sup> place CI Lamborghini Marque award, you will need to line up at approximately 2:15pm to drive your car to the CI stage. The LCA Chief Judges will instruct you on the details. If you are not available at this time, the judges will try to contact you but if unsuccessful they will move on to the next ranked car in their judging.
